Permission has been accorded to the Class (s) VI to X (E.M) for the years 2012-2013 in respect of Pragathi School, Pragathinagar, Kukatpally, Balanagar (M), Ranga Reddy Dist. in the orders first cited. The inspecting authority i.e., Dy.E.O. Malkajgiri, Ranga Reddy Dist. has submitted the report for provisional recognition to the school for the years 2012-2013 to 2021-2022 vide letter third cited. The Dist.Ednl.Officer Ranga Reddy Dist. has verified the application for provisional recognition with reference to the inspection report of the Inspecting officer and also with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2)Dept, dt.01.01.1994 and submitted a report in his letter 4th cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994, the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional Recognition to Class(s) VI to X (E.M) for the years 2012 - 2013 to 2021 - 2022 in respect of Pragathi School, Pragathinagar, Kukatpally, Balanagar (M), Ranga Reddy Dist. subject to fulfillment of conditions as detailed below:

01. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
02. That the educational Society shall serve the needs of locality more particularly.
03. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
04. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
05. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No. 103 Edn (PS), dt.05-08-2005.
06. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
07. That the records/accounts shall be furnished to the D.E.O every year by 31st March, at the latest.
08. That the list of governing body shall be furnished to the DEO every year.
09. That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.
11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.

12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide, the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognised/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bona-fied candidate.
19. The Edn.Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.6th cited.
20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P.Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc.,) without any deviation of the orders.
24. The Management is instructed to obtain NOC from Fire department.


The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the G.O 5th cited and instructions issued by the authority from time to time.

Provisional Recognition has been accorded for classes VI to X (EM) for a period from 2012-2013 to 2021-2022 by the RJDSE, Hyd through the orders 5th cited of “Pragathi School”, Pragathinagar, Kukatpally, Balanagar Mandal, Ranga Reddy Dist

The Deputy Educational Officer, Malkajigiri division , R.R Dist through the letter 4th cited has recommended to accord provisional recognition to classes I to X (EM) for the academic years 2012-2013 to 2021-2022

After careful examination of the proposals and recommendation of the Deputy Educational Officer, Malkajigiri division , R.R Dist and in terms of the orders issued in the references 1st & 2nd cited, the District Educational Officer, Ranga Reddy District is hereby accorded Provisional Recognition to classes I to V (EM) in respect of of “Pragathi School”, Pragathinagar, Kukatpally, Balanagara Mandal, Ranga Reddy Dist for a period of (10) years commencing from the academic years for the period 2012-2013 to 2021-2022 with instructions to follow the under mentioned instructions scrupulously.

1. That the society shall abide by the instructions/rules and regulations made by the Government or authorized officer time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed by Government from time to time.
4. The school timings, vacations and mid-term holidays shall be prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall appointed as per the staff pattern.
6. That the results of the institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the DEO, every year by the end of academic year at the latest. Fee structure fixed by the Governing Body which got approved in the order shall be complied with.
8. That all the conditions prescribed in the GO's and other orders which are not specified in the order shall be complied with.
9. That the school shall not be closed without giving notice to both the Parents and competent authority at least six months before.
10. That the list of Governing Body shall be furnished to the DEO every year.
11. That the school shall not be closed or permitted to be closed, only from the date on which summer vacation is declared.
12. That the society shall submit proposal for renewal of provisional recognition immediately in advance i.e., at least six months prior to the date of expiry of the renewal.
13. That additional sections/higher classes should not be opened without prior permission of the competent authority.
14. That the recognition is accorded to society and no other society or body can open a school on their behalf.
15. That recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
16. The society shall provide the necessary material even if it is costs more than the deposit amount.
17. Admissions should be made on the basis of Record Sheet issued by the Private recognized /ZP / Govt./Aided schools only. TCs/Certificates issued by the Secretary, DCEB as Bona-fied candidate.
18. The Educational Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Government from time to time by the end of April every year as per GO 2nd cited.
19. The above ETR is granted subject to conditions that, if it is found later that the school has not fulfilled the pre-requisite conditions under AP Education Act 1982 reported by State Level Inspection Teams and Vigilance Committee, the ETR now being granted is liable to be withdrawn at-once.
20. That the Educational Society shall follow the Examination schedule as per the time table issued by the DCEB and should conduct DCEB Question papers for Quarterly, Half-yearly, Annual and Pre-final examinations.
21. That the Educational Society should follow school timings as prescribed by Government in school academic calendar.

22. That the Educational Society shall not conduct any events for children which will harm to lives.
 23. That the Educational Society shall not conduct classes on public holidays/summer holidays/short term holidays without permission from the undersigned.
 24. That the Educational Society should constitute parents teachers committee and should conduct meetings with a committee once in a month.
 25. That the Educational Society should not open counters for selling books/badges/stationery etc.
 26. That the society/school shall abide by the provisional of Right of Children to Free and Compulsory Education Act, 2009 and the rules thereof.
 27. That the school management shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, its norm shall be followed.
 28. That the society/school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screen procedure.
 29. That the school management shall not deny admission to any child
 - a) for lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b) On the ground of religion, caste or race, place of birth or any of them.
 30. That the management of school shall ensure.
 - i) No child admitted be held back in any class or expelled from school till the completion of elementary education in a school
 - ii) child shall be subjected to physical punishment or mental harassment;
 - iii) No child is required to pass any board examination till the completion of elementary education;
 - iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23
 - v) Inclusion of students with disabilities/special needs as per provisions of the Act
 - vi) The teachers are recruited with minimum qualifications as laid under section 23 (1) of the Act. Provided. Further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
 - vii) The teacher performs his/her duties specified under section 24 (1) of the Act and
 - viii) The teachers shall not engage himself in private teaching activities.
 31. That the management of school shall enroll students proportionate to the facilities available in the school as prescribed in section 19 of the Act.
 32. That the management of school shall maintain the standards and norms of the school as specified in section 19 of the Act.
 33. No un-recognized class shall run within the premises of the school or outside in the same name of school.
 34. That the school buildings or other structures or the grounds are not used during the day or night for commercial or residential purposes (except for the purpose of residence of any employee of the school) or for political or non-educational activity of any kind whatsoever.
 35. That the school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force;
 36. That the school is not run for profit to any individual, group or association of individuals or any other persons;
 37. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements of Accounts should be sent to the District Educational Officer every year.
 38. The recognition Code Number allotted to your school is **6897/A5/2012**. This may please be quoted for any correspondence with this office in future.
 39. The school furnishes such reports and information as may be required by the by the Rajiv Vidya Mission / District Educational Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
 40. The recognition shall be withdrawn if the contravention of the provisions of the Act. The Rules and conditions of recognition is found and proved.
- The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the GO 1st cited and instructions issued by the authority from time to time.
